CMRL SPONSORED PG DIPLOMA COURSE IN "METRO RAIL TECHNOLOGY AND MANAGEMENT" AT IIT MADRAS

Chennai Metro Rail Ltd (CMRL), a Joint Venture company with equity participation from Govt. of India and Govt. of Tamil Nadu has been entrusted with the responsibility of implementation of the Chennai Metro Rail Project.

Applications are invited from dynamic and result oriented Engineers (Civil, Mechanical, Architecture, Electrical, Electrical & Electronics and Electronics & Communication Engineering), for the CMRL sponsored PG Diploma Course in "Metro Rail Technology and Management". The total number of seats is 13, which may undergo slight change.

<u>Age:</u> Not more than 28 years as on 31-07-2012 (relaxed by 3 years for OBC and 5 years for SC/ST).

Educational Qualification: First-class graduates with minimum aggregate average of 70% marks (relaxed by 5% for SC/ST candidates) in Civil/Mechanical/Electrical/ Electrical and Electronics/Electronics and Communication Engineering/Architecture from a recognized University/Institute are eligible to apply. The candidates should have qualified in GATE 2011 or 2012. Final year students who will secure the eligible degree before the commencement of the course can also apply.

<u>Selection Process:</u> The candidates short listed based on the GATE score and qualifying examination will be called for a test/interview which will be conducted at IIT Madras in coordination with CMRL. Final selection will be subject to medical fitness.

Stipend: For the one year course, CMRL will pay the candidates a stipend of Rs. 20,000/- per month and also the necessary sponsorship and tuition fees to IIT Madras.

<u>Induction:</u> On successful completion of the course, the trainees will be inducted as Assistant Manager, Chennai Metro Rail Ltd. in the relevant scale as per the HR policy of CMRL. Candidates who excel during the course and secure a CGPA of 8.5 or more, will

be granted two advance increments in Assistant Manager's grade upon joining, while others will be granted only one advance increment at the time of induction. Candidates who fail to complete the course will not be inducted in the Chennai Metro Rail Limited. They will have to pay a bond amount of Rs.5 Lakh to Chennai Metro Rail Limited towards training cost. Those Trainees who successfully complete the course but do not join Chennai Metro Rail Limited within ten days of completion of the course, their candidature will lapse and they will also have to pay an amount of Rs.5 Lakh to Chennai Metro Rail Limited as bond amount.

Bond & Notice Period time: Before joining the course, the selected candidates will have to execute a bond of Rs.5 Lakh to serve Chennai Metro Rail Limited for a period of four years (This is inclusive of the PG Diploma course period of about one year). They will also have to give a notice of three months (working) if they want to leave Chennai Metro Rail Limited at any pint of time during the bond period.

<u>Seniority:</u> The inter-seniority of the Executive Trainees in the concerned discipline at Assistant Manager Level will depend on the overall performance at the Post Graduate Diploma Course at IIT Madras. Further, their seniority, in the discipline concerned, upon absorption, will count retrospectively from the date of start of the course at IIT Madras.

<u>Probation:</u> After induction as Assistant Manager, they will be on probation for a period of two years. After successful completion of probation, they will be confirmed as per the HR Policy of CMRL.

How to Apply: Duly filled in application form (**See Annexure for application form**) along with the Application Fees should be sent in an envelope super scribing on the cover- "Application for PG Diploma course" and the name of discipline to reach the following address latest by 20-04-2012.

The Programme Coordinator CMRL sponsored PG Diploma Course Department of Civil Engineering IIT Madras, Chennai-600 036 Application Fees: The candidates will have to enclose a non-refundable crossed Demand Draft for Rs. 300/- for General & OBC candidates and for Rs. 50/- for SC/ST candidates (for processing cost only) along with application form drawn in favour of CHENNAI METRO RAIL LIMITED, payable at Chennai indicating on the reverse of the DD, their name, address and telephone no., if any. Demand Drafts payable at locations other than Chennai will not be accepted. MO/PO or any other mode of payment is not acceptable. Candidates are advised to check the details of Demand Draft carefully before enclosing it with the application form. Candidates should retain a photocopy of their demand draft and application form for future reference. They should also keep sufficient numbers of copies of the same Photograph (Coloured) in reserve for future use, which they are pasting in the application form. The photograph (Coloured) should not be more than six months old. Incomplete applications or applications received without demand draft or received after the due date will be summarily rejected. Chennai Metro Rail Limited will not be responsible for any postal delay/loss in transit. No request in this regard will be entertained.

Note:

- (1) The interviews will be held at IIT Madras.
- (2) The candidates applying should ensure that they fulfill all eligibility conditions for admission. Their admission at all the stages will be purely <u>provisional</u> subject to satisfying the prescribed eligibility conditions.
- (3) Mere issue of admission to the candidate will not imply that his/her candidature has been finally cleared by Chennai Metro Rail Limited. Chennai Metro Rail Limited will take up verification of eligibility conditions with reference to original documents at the time of Interview/Group Discussion.
- (4) No TA/DA for attending the interview.
- (5) Candidates are informed that selection is strictly as per CMRL selection process. Any attempts to influence or tamper with the selection process will cause summary disqualification of the application.
